

Course on Safety Assessment of Cosmetics 6-11 Nov 2017

Cosmetics Regulation in Indonesia and ASEAN countries put the responsibility of safety in the hands of the industry. This responsibility can be carried out only if there is ability to evaluate the safety of cosmetics. The activity of assessing cosmetic's safety is not a simple one, it includes understanding of many concepts and practising data evaluations. This ability has some basic knowledge as a background plus additional training in an intensive course.

The Continuing Medical Education, Department of Pharmacology & Therapeutics, Faculty of Medicine, Universitas Indonesia has been very familiar with safety assessment concept of any human intervention. We have a long history of activities, research and service in toxicological studies as well as in vitro and in vivo animal and human studies.
